## **Activity Waiver**

In consideration of permission granted by Sunshine State Secular Homeschoolers (SSSH) allowing me to participate in [activity] (together with my parent or guardian, if I am under the age of eighteen (18) or under a legal disability) represent, covenant and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, under or through me, as follows: I acknowledge that participating in the Activity involves certain risks (some of which I may not fully appreciate) and that injuries, death, property damage or other harm could occur to me or others. I accept and voluntarily incur all risks of any injuries, illnesses (including COVID-19), damages, or harm which arise during or result from my participation in the Activity, including any associated travel, regardless of whether or not caused in whole or in part by the negligence or other fault of SSSH and their directors, officers, employees, volunteers, donors, representatives and agents, vendors, independent contractors, the event sponsors and event volunteers, agents or insurers ("Released Parties"). I waive all claims against any of the Released Parties for any injuries, illnesses, damages, losses or claims, whether known and unknown, which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. I release and forever discharge the Released Parties from all such claims. I agree to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. I understand that at this event or related activities I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by SSSH representatives. I hereby release and agree to hold SSSH harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with attending the Activity with SSSH. I understand that this release discharges SSSH from any liability or claim that I, my heirs, or any personal representatives may have against SSSH with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, attending the event. This liability waiver and release extends to SSSH together with all owners, partners, and employees. I have carefully read and reviewed this Waiver. I understand it fully and I execute it voluntarily. By joining SSSH, I specifically agree to the above Waiver and understand that it applies to any and all in person events.
