_____ I understand that Nevada Revised Statute 392.040- 392.125 mandates that children age 7-18 must be enrolled in public school unless legally excused. I affirm that my child is younger than Nevada's mandatory school age.

_____ I understand that HCH Co-op classes are supplemental to what is being taught in the home and are meant for enrichment purposes only. As the parent, I also realize that these classes will not complete any curriculum, only enhance them. The instructors do not teach the entire subject matter, but are only enriching and assisting instruction at home.

_____ I understand that HCH does not give legal protection or legal assistance. Also HCH is not obligated to testify regarding my homeschool's or child care provider's validity, authenticity, or effectiveness to legal authorities or in court.

_____ I understand that HCH does not keep permanent records or assign grades.

_____ I agree that my child will be read and will strive to abide by the Student Agreement to the best of their ability.

_____ I understand and agree that the adult listed above must remain on the premises the entire time and be responsible for my child whenever they are participating in co-op.

_____ I understand that other HCH Co-op parents may instruct classes that my child is in or otherwise care for my child and that the adult listed above may not be present. I agree to abide by the In Loco Parentis's discretion in such instances.

_____ I understand that HCH Co-op serves solely as a support group and enrichment cooperative program and is not responsible for the education of my children.

_____ I understand and agree that it is my responsibility to be aware of, and in compliance with, the laws governing education in the state of Nevada.

_____ I understand and agree that HCH's Board, Co-op Co-ordinator, other Coordinators, Instructors, and Hope Church will at no time be responsible for mishaps, injuries, or accidents that may occur during the year.

_____ I acknowledge that participation in all activities involves risk of personal injury. Furthermore, I understand that laboratory activities may include handling hazardous chemicals, biological substances, sharp objects, heat, etc. I hereby release, discharge, and hold harmless HCH and Hope Church, its representatives, teachers, volunteers, and members from any claims arising out of, or relating to, physical or other injury that may result while participating in HCH events.

_____ I have read, understand, agree to abide by the Discipline and Standards Policy, Refund Policy, Illness Policy, Special Needs and all other applicable information in the Henderson Christian Homeschool Co-op Handbook.
