Release of Liability

1. I agree that I am personally responsible for my safety and the safety of my child or children or the child or children for whom I am responsible while participating in any activity hosted or coordinated by the Henderson Christian Homeschoolers (referred to as "HCH"). I agree to comply with all HCH policies, rules, guidelines, and instructions. Because HCH is open to other parents, responsible parties, and children, I recognize that my participation and the participation of my child, children or the child or children for whom I am responsible in HCH activities places each of us at a higher risk of contracting a communicable disease or otherwise be injured.

2. The risks of illness from communicable diseases (including, but not limited to, MRSA, H1N1, influenza, SARS, Covid-19, mumps, measles, and chicken pox) or injury from participating in activities and classes with other parents and children provided by HCH are significant and while the safety practices, rules and procedures adopted by HCH may reduce these risks, serious risks will still exist; and

I KNOWINGLY AND WILLINGLY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF HCH AND THE OTHER PARTIES RELEASED, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION AND THE PARTICIPATION OF MY CHILD, CHILDREN OR THE CHILD OR CHILDREN FOR WHOM I AM RESPONSIBLE.

3. I willingly agree to comply with the safety practices, rules and procedures adopted by HCH to participate in HCH classes and activities. If I observe any unusual hazard or risk during my presence or participation, I will remove myself, my child or children and the child or children for whom I am responsible from participation and will bring such hazard or risk to the attention of the nearest HCH official.

4. The activities and classes provided by HCH are of such value that I accept the risks from participation rather than arranging for an alternative method of participating in the same activities and classes like videoconference, Zoom, or some other method.

5. I HEREBY FOREVER RELEASE AND WAIVE MY RIGHT TO BRING A LAWSUIT AGAINST HCH AND ITS OFFICERS, MANAGERS, DIRECTORS, OFFICIALS, INSTRUCTORS, AGENTS, EMPLOYEES OR OTHER HCH REPRESENTATIVE (referred to as "Releasees) IN CONNECTION WITH THE NEGLIGENT EXPOSURE TO A COMMUNICABLE DISEASE OR ANY OTHER CAUSE OF INJURY AND I WILLINGLY GIVE UP MY RIGHT TO BRING ANY CLAIM OR SEEK ANY DAMAGE FROM THE RELEASEES.

6. I understand and agree that the laws of the State of Nevada will apply to this contract.
